Students across Wisconsin prepare to compete in Mock Trials

February 11, 2010 – Students from nearly 90 Wisconsin high school teams will gather in courthouses and other venues across the state on Saturday, February 13 to compete in the 27th Annual Wisconsin High School Mock Trial Tournament sponsored by the State Bar of Wisconsin. Fourteen teams will move on to statewide competition in Madison on Sunday, March 14 and Monday, March 15. The team that finishes first in that competition will go on to represent Wisconsin at the National Mock Trial Championship in Philadelphia on May 6 – 8.

Mock trials, which follow the rules and structure of a "real" court trial, offer teams of six to twelve high-school students the opportunity to argue a case before a three-person panel of judges, composed of volunteer attorneys and jurists. "This is an exceptional opportunity for students to gain a deeper understanding of our justice system and the rule of law while also developing critical thinking, public speaking, teamwork and other life skills that will serve them well throughout their careers," explains Atty. Michael Rosenberg, who helped develop the case materials for this year's competition.

Rosenberg also praises the hundreds of volunteer lawyers, judges and teachers who will also be on hand on February 13 to give students realistic insights into court operations. Mock Trial competitions are open to the media and public from 8:00 AM to about 5:00 PM. This year's competition will wrestle with the issue of negligence vs. confidentiality in a claim that a psychiatrist was negligent in the treatment of a young man who voluntarily admitted himself to hospital when his girlfriend left him. After the young man was released from hospital, he murdered his girlfriend before committing suicide. The parent of the girlfriend is suing the doctor and hospital, claiming that they were negligent when they released the young man, and failed to warn the young woman her ex-boyfriend wanted to hurt her. Does the parent have a point or was the psychiatrist rightfully protecting the patient's right to confidentiality? (Note: the case is entirely fictional.)

The fourteen teams that will go on to compete in the state finals include each of the regional winners; the second place team from the 2009 winning region and three wildcard teams.
