Understanding the Legal Landscape

There are three entities created by the Wisconsin Supreme Court, each with different functions.



- OLR: <u>The Office of Lawyer Regulation</u> investigates lawyer misconduct. The Supreme Court, if appropriate, issues fines/penalties.
- BBE: The <u>Board of Bar Examiners</u> tests the skills, character, and fitness of lawyers seeking to enter the practice. Out of state lawyers must pass the bar exam or have actively practiced elsewhere to receive a law license.
- SBW: <u>The State Bar of Wisconsin</u> supports all attorneys licensed to practice by delivering valued professional services, promoting access to justice, and pursuing professional satisfaction.

The State Bar has 26 sections that represent various areas of law. 15 of them lobby. Section lobbying positions are independent from those of the Board of Governors. When mentioning a position taken by a section,, use the specific section name, like "The Family Law Section of the State Bar of Wisconsin," instead of just "The State Bar of Wisconsin." The State Bar serves the public by supporting access to justice through free legal assistance, estate planning, lawyer referrals, small business legal help, and public education.

The State Bar advocates for a stronger justice system and provides administrative support to the Wisconsin Court system. It also publishes official notices, disciplinary decisions, and court digests, while maintaining records for over 25,000 attorneys.

The State Bar supports its members with ethics counsel, small business advice, advanced continuing legal education, and well-being consultations.
